- 4. How to Receive a Home Improvement Project. Each quarter, one or more judges ("Judge(s)") from BNW Builders will evaluate and judge the entries and determine a Project Recipient. Project Recipients will be selected based on the Judge(s)' evaluation of the need for the home improvement project, the condition of the current exterior of the home, the ability to use the materials provided by BNW Builders for the project, the time frame for performing the project, and the perceived overall lifestyle improvement the project will create for the homeowner(s). The judges, in their sole discretion, will evaluate each entry based on these criteria in their sole discretion and will select a pool of semi-finalists. The four Project Recipients will be selected from the semi-finalist pool by the Judge(s), following the Judge(s) further evaluation (which may include, among other things, site visits and interviews) of the semi-finalist entries. Each of the four Project Recipients will be notified within 2-3 weeks of their project start date that they have been selected to be a Building Needs and Wishes Project Recipient. The estimated and desired project timeframes are: Project #1-Sept/Oct 2016, Project #2 – January 2017, Project #3 –March/April 2017, and Project #4- June/July 2017. The Sponsors anticipate completing each home improvement project during one of the designated project timeframes and at the discretion of iHeartMedia and BNW Builders. At the completion of each project iHeartMedia will showcase, in a manner left to the discretion of iHeartMedia, the home improvement project completed by BNW Builders. All dates and timeframes are subject to change at the Sponsors' discretion, based on a variety of factors including without limitation convenience to BNW Builders or iHeartMedia, weather, material supply and demand, labor supply and demand, and changes in the ownership of

5. Home Improvement Projects and Odds of Being Selected One exterior home improvement of the existing home will be granted to each of four (4) Project Recipients. The size and general restrictions of the existing home will dictate the services and products to be included. All renovation and all home improvement decisions will be made by BNW Builders in their sole discretion. The exterior home improvement will be limited to one (1) structure. The approximate value of the materials and labor used in this home improvement will be between \$5,000 and \$40,000 and will vary based on BNW Builders' judgment concerning the home improvement and the recipient's existing home. Sponsors do not guarantee that any Project Recipient will receive labor and materials valued at \$40,000. BNW Builders has worked to provide pre-selected items for the home improvement projects free of charge. The exterior home improvement may or may not increase or decrease the overall value of the home. Sponsors make no warranty relating to increasing or decreasing home value.

All charges, fees, and costs not specifically included in the home improvement project descriptions above, including but not limited to any and all personal incidental items, transportation, taxes, permits, and licenses, are the responsibility of the Project Recipient.
